Declaration of Conformity

Implementation of the European RoHS Directive I, II, III (2002/95/EG) (2011/65/EU) (2015/863/EU)

No Pb (lead), Hg (mercury), Cd (cadmium), CrVI (hexavalent chromium), PBB (polybrominated biphenyl) resp. PBDE (polybrominated diphenylether) and Bis(2-ethylhexyl) phthalate (DEHP) (0.1 %) Butylbenzylphthalate (BBP) (0.1 %) Dibutylphthalate (DBP) (0.1 %) Diisobutylphthalate (DIBP) (0.1 %) in electrical and electronic appliances put into circulation.

Implementation of the European Directive WEEE (2012/19/EU)

Reduction of the quantity of waste by avoidance, re-use and recycling of old appliances. Marking of electrical and electronic appliances put into circulation after 13 August, 2005. Selective treatment pursuant to Annex III, 1.c) Printed circuit boards of mobile telephones in general and other appliances, if the surface of the printed circuit board is >10 cm²

Implementation of the European Directive on End-of-Life Vehicles (2000/53/EG)

Prevention of waste arising from end-of-life vehicles, reduction of waste disposal, better environment protection by all economic operators involved in the life cycle of vehicles.

No Pb, Hg, Cd and CrVI in materials or components of vehicles put into circulation after 1st July 2003. Exception: Annex II for Pb as solder flux in electronic PCBs and other applications.

Implementation of the European Directive concerning the Registration, Evaluation, Authorisation and Restriction of Chemicals (REACH) (1907/2006/EG)

Establishing a European Chemicals Agency, amending Directive 1999/45/EC and repealing Council Regulation (EEC) No 793/93 and Commission Regulation (EC) No 1488/94 as well as Council Directive 76/769/EEC and Commission Directives 91/155/EEC, 93/67/EEC, 93/105/EC and 2000/21/EC
